Republican Priorities: BALANCE THE BUDGET

- NO Tax Increases
- NO Spending Increases
- Review all 2011 Malloy tax hikes and reduce if possible
- Require strict adherence to the spending cap
- Require that consensus expenditure projections are provided, just as consensus revenues are provided
 Reduce Pension Liabilities
 - Get Serious About Fraud Prevention
 - DSS & Chief States Atty. Identify existing staff to dedicate to enforcement & protection
 - Prohibit use of government benefits for products such as cigarettes & alcohol

Republican Priorities: <u>ECONOMIC DEVELOPMENT & JOB CREATION</u>

Regulatory Reform

- Moratorium on any new regulations
- Expedite the permit approval process
- 90 day max for state review/action on permit approval process
- Expedite completed, viable permits and funding applications
- Review costs and environmental benefits of existing regulations
- Convert lower-level "permits" to enforceable "guidelines"
- Require quantitative & qualitative assessment of costs and benefits
 of new regs

Provide targeted tax relief to citizens

- Provide tax relief for companies who purchase commercial property in CT
- Repeal the corporate surcharge for 2013
- Expand the scope of Learn Here, Live Here include ability to purchase first home, pay off school loans or start a business
- Create a Small Business Reinvestment Account Program

Republican Priorities: <u>Economic Development & Job Creation</u>

- Increase the dispensing fee for independent pharmacies; eliminate mail order requirement in SEBAC
- Create a new Connecticut Startup Program
 - Gas Tax Relief Cap the Gas Tax Fund the Underground Storage Tank Program
 - Require regular reporting on the status of state-subsidized economic development projects to ensure both the state and the businesses are meeting their obligations

Republican Priorities: EDUCATION REFORM

- Much of what the Governor proposed is not new, and there is much we agree with, including:
 - Reforming the Teacher Tenure System
 - Greater resources for charter schools
 - Turnaround Schools Startup
 - School certification reciprocity
- There are areas where we disagree with the Governor:
 - Money for reforms should be in lieu of, not in addition to, current spending
 - No forced regionalization
 - The Governor's ECS formula does not work
 - We do not believe the Governor's metric accurately measures the wealth, and need, of our cities and towns.
 - Other Republican Proposals
 - Summer Bridge
 - Provide funding for Science, Technology, Engineering and Math for middle schools
 - Career Cluster
 - Expand parental & school choice
 - No unfunded school mandates
 - Allow online remedial courses for students identified as "needing improvement"
 - Establish a tax credit program for the donation of equipment to VoTech schools

Republican Priorities: <u>TRANSPARENCY & ACCOUNTABILITY</u>

Address critical infrastructure deficiencies

- Stop the New Britain-Hartford busway
 - Current bureaucratic and legal hurdles are making this project less and less likely it will come to fruition in the near future.
 - Let's free up the funds and redirect them to fix crumbling bridges, roads and dangerous thoroughfares

Risk Reduction Credits

- Require the Department of Corrections to report outcomes relating to the Early Release of Prisoners
 - Crimes committed, eligibility, recidivism rates, etc.

The legislature should receive a cost/benefit analysis for large capital projects

Republican Priorities: TRANSPARENCY & ACCOUNTABILITY

- Require up or down votes on agreements negotiated by the executive branch
 - Particularly all collective bargaining agreements, forced unionization
- Ensure the autonomy of watchdog agencies
 - Only the legislature should be able to reach their budgets
 - Under the Office of Government Accountability, if these agencies have the power to fire the executive administrator they should also have the ability to set standards for his performance; clarify existing law

Restore the autonomy and independence of PURA assuring they are not susceptible to political influence

Republican Priorities: <u>GENERAL GOVERNMENT REFORM</u>

- Improve both state and local response to natural disasters and require the same from the utilities
 - Authorize PURA to develop performance standards for utilities
 - Centralize coordination of government efforts to respond to emergencies
 - Require electric utilities to train municipal employees in how to identify live wires
 - Eliminate longevity payments, and prohibit longevity and overtime pay from being used in pension calculations.
 - Suspend the COLA on all CEP grants, reduce amounts of CEP grants by 10% and redirect those funds to restore the Medicaid Personal Needs Allowance.
 - Establish Privatization Planning Committee to develop a plan to privatize direct-care services
