Remembering Broko



Sen. Somers authored "Broko's Bill" (S.B. 339) to provide restitution to municipalities for police canines injured or killed in the line of duty, honoring the sacrifice of Police K-9 Broko who was killed late last year.

Insurance Coverage of Coronary Calcium Scans

Ensures access to preventative care by requiring insurance coverage for life-saving Coronary Calcium Scans to combat heart disease.

Home Health Safety Related Client Intake

Mandates the sharing of relevant patient history information before home visits to protect home healthcare workers.

Opioid Deactivation and Disposal Systems

Allows pharmacists to provide information on opioid disposal systems, helping to remove unused medications from the streets.

Fairness in Nursing Home Applications

Prohibits nursing homes from denying admissions solely based on an applicant's history of receiving mental health services.
